### **New Courses**

a. Course Subject/Number: (Allied Health 101)

Title: Nursing Pharmacology

Rationale: This course is designed for allied health and nursing student to become familiar with drug use and therapy needed for practice as a healthcare professional. This course is designed for students to solve basic dosage calculation problems needed in healthcare as well as have a general understanding of pharmacology and medication administration. This course is necessary to provide basic pharmacological knowledge and skills to meet the entry level competencies described by the Board of Vocational Nursing and Psychiatric Technicians for LVNs. This course is a pre-requisite to the LVN program at Crafton Hills College.

g. Course Subject/Number: (English 104)

Title: Writing the Research Narrative

Rationale:

- 1. The course meets students' need for a writing course devoted to crafting a fully developed and comprehensive scholarly research paper.
- 2. The course provides students with a sophisticated knowledge of the standard practices of writing research papers and provides a skill set that will transfer for use in any other course that has a formal research writing requirement.
- 3. When taken concurrently with PSYCH101 (Research Methods), the combination is typical of the requirement for upper division Research Methods course at CSU.
  - 4. The intention of the course will be to satisfy the associate degree requirement D4 (Language and Rationality, Critical Thinking and Information Literacy).
